1. *Arnama Rural Municipality has allocated funds from GoN towards the cost of Arnama Gaupalikako Prashasakiya Bhawandekhi Gotahahudai Krishanapur Ma. Bi. hudai 5 na. wadakaryalayahudai Hulakisadaksanuna Kalopatra* and intends to apply part of the funds to cover eligible payments under the Contract for IFB No:- 02/WORKS/ARNRM/NCB/082-83. Bidding is open to all eligible as per Section V of bidding document.
2. *Arnama Rural Municipality* invites electronic bids from eligible bidders for the construction of *Construction of Black Top Road* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: *NRs. 7,12,00,000.00 (Seven Crore Twelve Lakhs Only)*
 - Minimum Work experience of similar size and nature: *Construction of Cement Treated Sub-Base/ Base Black Top Road of Amount not less than 7,60,00,000.00 (Seven Crore sixty lakhs only.)*
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of *Arnama Rural Municipality, Office of Rural Municipal Executive, Arnama Siraha, Madhesh Province Nepal. Email:- ito.arnamamun@gmail.com* or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. A complete set of Bidding Documents may be submitted by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of *Nrs. 10,000* till *15th Dec 2025 12:00 PM*

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the account as specified below.

6. Pre-bid meeting shall be held at **Arnama Rural Municipality** at **10th Dec 2025 3:00 PM**.
7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egpon or before **12:00 PM** on **15th Dec 2025**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2 PM on 15th Dec 2025** at the office of **Arnama Rural Municipality**. Bids must be valid for a period of **(120+30)=150 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs. 26,00,000, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
