7. Electronic bids must be submitted through PPMO's e-GP system <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a>on or before 12:00 PM on 15th Dec 2025. Bids received after this deadline will be rejected.

8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2 PM on 15th Dec 2025 at the office of Arnama Rural Municipality. Bids must be valid for a period of (120+30)=150 daysfrom the bids ubmission deadlineand must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs. 26,00,000, which shall be valid for 30 days beyond the validity period of the bid.

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
